## 3. Road and Drainage Chair Report

Chris reported that clearing of brush on Acorn Ct was done on March 16 and that there is brush to burn at the pond.

## 4. Pond and Dam Report

### a. Work on the dam road to discourage vehicles on dam

Still waiting for Alex to finish the center post. Chris will put up a chain in the meantime.

### b. Dam Inspection

On April 15, 2016 Chris will meet with the Dam inspector. As of January 2018 we will be required to monitor water level on the pond monthly. Chris suggested installing a water level logger in the fall of 2017.

#### c. Work done

Chris mowed the pond and trimmed brush on Acorn. He brought 5 trailer loads of brush to the pond to be burned.

#### d. Blackberries

All Phase said it is too wet to cut back the berries and to wait until June.

### 1. Approval for Purchases

A water pump is needed to water seeded area from the water tank. A motion was made by Valerie and 2nded by Donna to approve a pump up to \$150.00.

## 2. Requests for reimbursement based on approved purchases

Chris requested reimbursement for water tank piping (\$17.46) and 5.2 hours of tractor work at the pond for a total \$147.46.

### 3. Fire Safety Council update

Valerie mentioned that the tree trimming on Rattlesnake Bar Road was done because we are a "community at risk". Valerie has sent out a flier for the first community event on April 25 when Emergency Preparedness will be discussed. The second community event in June will discuss Evacuation.
